Course Description

Surveys intellectual, cultural, social, economic and religious patterns in the civilizations of the Middle East. Covers Semitic, Indo-European, and Turkic-speaking peoples from pre-Islamic to the present. Part I of II.

This course is an introduction to the history and civilization of the modern Middle East (West Asia - North Africa). This course begins as a survey of early history of the region, commencing with the origins of Islam. The course reviews the pre-modern empires of the region, their subsequent collapse; then renaissance of the 19th and 20th centuries and move toward independence. The course examines the newly emergent "Islamist" and Pan-Arabism" ideologies of the late 20th and early 21st centuries. Students will analyze significant political, socioeconomic, and cultural developments in pre-modern world civilizations.

Students will be introduced to useful skills for historical analysis and interpretation. Students will strengthen skills in interdisciplinary studies and global awareness.
